SUMMARY STATEMENT TO SUPPORT PROBABLE CAUSE:

I, Deputy Director Richard Wozniak, do hereby swear or affirm that I have the following cause to believe the individual named committed the alleged offense(s) for the reasons stated in this Affidavit in Support of Probable Cause:

1. I have personal knowledge of the facts listed in the statements of facts as I was involved in the underlying investigation.
2. The summary statement of facts to support probable cause is as follows:
 - a. I am a Deputy Director of the Department of Public Safety for the City of Columbus. I have been assigned to investigate potential criminal police misconduct that occurred during the protests in the summer of 2020.
 - b. On May 30, 2020, Kanode was working as a police officer for the City of Columbus near the intersection of Broad Street and High Street during one of the protests. The Body Worn Camera (BWC) of Kanode showed Kanode assisting in the arrest of Nadia Lynch.
 - c. At the arrest scene Kanode can be heard on her BWC telling another Officer (PO#1) that Lynch had grabbed hold of another Officer and jerked him to the ground with his gear. PO#1 then used the information provided by Kanode to complete the arrest report for Lynch.
 - d. A review of Kanode's BWC did not show Lynch grabbing and throwing any police officer to the ground. Another video showing the arrest of Lynch was submitted to the City. A review of this video also did not show Lynch grabbing and throwing any police officer to the ground.
 - e. Holly Kanode while employed as a public official/employee under 2921.01 of the O.R.C. (a sworn law enforcement officer) whose duties included but not limited to upholding and enforcing the laws of the City of Columbus and the state of Ohio did knowingly make

a false statement and was derelict in her duties as a sworn law enforcement officer in violation of O.R.C. 2921.13 (A) and 2921.44 (E).

I, Richard Wozniak, knowingly swear or affirm that all of the information contained in this Affidavit in Support of Probable Cause is true to the best of my belief and/or knowledge.
