**SUMMARY STATEMENT TO SUPPORT PROBABLE CAUSE:**

I, Deputy Director Richard Wozniak, do hereby swear or affirm that I have the following cause to believe the individual named committed the alleged offense(s) for the reasons stated in this Affidavit in Support of Probable Cause:

1. I have personal knowledge of the facts listed in the statements of facts as I was involved in the underlying investigation.
2. The summary statement of facts to support probable cause is as follows:
  - a. I am a Deputy Director of the Department of Public Safety for the City of Columbus. I have been assigned to investigate potential criminal police misconduct that occurred during the protests in the summer of 2020.
  - b. On May 29, 2020, Walls was working as a police officer for the City of Columbus during the protests. Walls was also wearing his Body Worn Camera (BWC) on this date. A review of Walls BWC determined the following:
  - c. Walls and other bike officers from the Columbus Police Department (CPD) were gathered outside of CPD headquarters. Walls and the other bike officers were instructed to go to the corner of Broad Street and High Street to clear the street.
  - d. Walls and the other CPD bike officers then traveled on their bikes to the corner of Broad Street and High Street where the bike officers dismounted. Walls was observed on his BWC pepper spraying peaceful protestors who are standing on the sidewalk.
  - e. Rick Lane, one of the protestors that Walls pepper sprayed, was interviewed regarding this event. Lane was shown the video from Walls' BWC. Lane identified himself and an unknown older black female (Jane Doe) being pepper sprayed by Walls in Walls' BWC

video. Lane and Jane Doe were standing on the sidewalk and Lane was helping Jane Doe who had been previously been pepper sprayed. After initially pepper spraying Lane and Jane Doe, Walls again pepper sprays Jane Doe and another unknown female who was trying to help Jane Doe leave the area.

- f. Phillip Walls while employed as a public official/employee under 2921.01 of the O.R.C. (a sworn law enforcement officer) whose duties included but not limited to upholding and enforcing the laws of the City of Columbus and the State of Ohio did assault Rick Lane and Jane Doe, was derelict in his duties as a sworn law enforcement officer and interfered with Rick Lane's and Jane Doe's Civil Rights in violation of O.R.C. 2903.13 (A), 2921.44 (E) and 2921.45.
